Step 6 Epson will send you prepaid shipping labels.

We will send you pre-paid FedEx labels which must be affixed to the container of eligible scanner equipment you are trading in.

Step 7 Send us your trade-in scanner equipment.

Please do not re-box each scanner; place as many in one box as possible.

Eligible trade-in scanners* must be received by Epson within 60 days of CaptureOne purchase.

Epson will send you a check for the approved number of scanners received. Please allow 8–10 weeks for receipt of your rebate check after shipping the trade-in equipment.

Terms of rebate:

- Receive a \$150 rebate when you trade in a multi-feed scanner* and purchase an Epson CaptureOne 90 DPM scanner.
- Receive a \$100 rebate when you trade in a multi-feed scanner* and purchase an Epson CaptureOne 60 DPM scanner.
- Receive a \$50 rebate when you trade in a multi-feed scanner* and purchase a CaptureOne 30 DPM scanner.
- Receive a \$25 rebate when you trade in a single-feed scanner* and purchase any CaptureOne model.
- Receive a \$25 rebate when you trade in a single-feed scanner* and purchase a CaptureOne single-feed scanner.
- Receive a \$15 rebate when you trade in a multi-feed scanner* and purchase a CaptureOne single-feed scanner.
